In order to make this information available to everyone, Red Rocks Community College annually distributes and makes available several reports and statistics to students, prospective students and employees. This information is available through a variety of sources, including the RRCC website, Student Handbook and other printed materials. The purpose of this notice is to make you aware of these reports and where you can find them.

These reports provide a great deal of information on topics ranging from educational programs to items required by federal law. The following reports are available in a variety of formats. For those reports available on the Internet, hard copies will be provided upon request. Much of the same information is also available in the RRCC Student Handbook, <http://www.rrcc.edu/handbook/index.html> and is available at a variety of locations around campus, including the Offices of Student Life and the Vice President for Student Services.

1. RRCC publishes a Campus Security Report annually. This report contains:
  - Crime statistics for the previous three calendar years concerning reported crimes that occurred on campus, in certain off-campus buildings or property owned or controlled by RRCC, and on public property within, or immediately adjacent to and accessible from, the campus.
  - Campus policy regarding the reporting of criminal activity and facility access.
  - Campus policy and services regarding law enforcement and public safety.
  - Information regarding safety and crime prevention programs.
  - Campus policy for the recording of off-campus criminal activity.
  - Campus policy regarding the sale, possession and use of alcohol and illegal drugs.
  - Information regarding drug and alcohol education programs.
  - Policies and procedures for preventing and responding to sexual offenses.
