



Financial Declaration Requirements and Affidavit of Support

If it is determined that you are admissible to Red Rocks Community College, RRCC can provide you with an I-20 (F-1) or I-20 (M-1) only after you submit satisfactory evidence that you have adequate funds for your proposed program of study. Acceptable financial documents must have been issued (by the financial institution) within 3 months of the date the Application form was submitted with the Affidavit of Support (below) if necessary. Please refer to the international student application for the financial amounts required to be shown at the time of application. Be sure to keep copies of your financial documents as you will need to present them to the US Consular Officer at your visa interview and to the US Immigration Officers at the Port of Entry.

Parent/Personal sponsor whose name is on financial documents must complete this portion.

Spouses, relatives and other personal sponsors are required to complete the "Affidavit of Support" form when funds held in their name are provided as financial documentation by an international student at time of application. The Affidavit of Support helps confirm the legitimacy of financial documentation presented by the student. See page three (3) of this document for financial estimates.

Certification of Financial Support

Example Sources of Funding and Required Documentation. All amounts must be in United States currency or show applicable conversion rate.

Source of Funding	Required Documentation
Personal bank statement (checking/savings)	Certified bank letter/bank statement
Parent(s) /Personal sponsor(s)	Affidavit of Support (attached) AND certified bank letter/bank statement
Government agency (<i>home country</i>)	Letter of award

REQUIREMENTS FOR DOCUMENTATION OF FUNDS

- Official and original dated bank statement(s) must be provided.
- All accounts must be easily accessible and liquid assets.
- Electronic documents are acceptable, but must clearly be from an original document.
- All documents must be in English. Otherwise, an official English translation must accompany the original.
- All supporting documentation must be dated within three months of application.
- Letters of sponsorship must include exact dollar amount of support (in US dollars) and dates of sponsorship.

The following may not be used as documentation of funds:

- Statements verifying employment and salary
- Insurance premiums and policies
- Property or personal assets (automobiles, land, buildings, jewelry, etc.)
- Non-liquid assets such as stocks, bonds, equities, retirement accounts
- Income tax returns
- Attestations stating only that a sponsor can meet the expenses
