### Responsibilities

Teach using traditional and alternative methods of instruction including hybrid delivery and skills simulation. Demonstrate understanding of and sensitivity to different student learning styles. Develop and/or teach nursing courses and/or other courses ensuring compliance with DORA and other relevant agencies. Proficiency in areas of instruction, program administration/evaluation, and clinical coordination. Participate in assessment and use data to improve student learning. Coordinate with other faculty and health programs in curriculum planning, development, delivery and review. Recruit, advise, and retain students. Hold office hours. Assume department duties as needed. Participate in department, division, and college-wide professional development activities and committees. Serve as a liaison between Red Rocks Community College and the health care community.

**Minimum Qualifications:** Registered Nurse licensed in the State of Colorado. Bachelor's Degree in Nursing or related field. Ability to obtain the appropriate Career and Technical Education (CTE) credential: Demonstrate adequate occupational experience by documenting 4,000 hours of verified, paid occupational experience in the credential area within the past 5 years. Proficient understanding of Nursing education and licensure regulations and guidelines. Ability to teach a diverse schedule, including classes

that meet during the days, in the evening or on weekends. A strong commitment to creating an environment, which fosters inclusiveness and diversity.

**Preferred Qualifications:** Master's degree in Nursing. Experience teaching at the community college level and developing curriculum.
