Red Rocks Community College is pleased to offer G.E.D. scholarships. Read the ENTIRE application carefully, including the program policies. Completing this application does not guarantee a scholarship award. Selection is based on a competitive evaluation of an applicant's G.E.D. test scores, professional and academic goals and special circumstances. Your eligibility will be checked prior to the selection process.

ELIGIBILITY GUIDELINES: Applicants must meet ALL guidelines to apply:

- 1. Applicant must have received their G.E.D. from January 2012 through the present.
- 2. Applicant must be a U.S. citizen or a Permanent Resident.
- 3. Applicant must be a Colorado resident for a period of at least one year prior to the application deadline.
- 4. Applicant must provide a copy of their official G.E.D. test scores with the application.

Application Instructions:

Applicants must complete ALL PARTS all parts of the application to apply:

- 1. Complete all sections of the Biographical Information pages.
- 2. Submit a Personal Statement.
- 3. Provide one or two letters of Recommendation.
- 4. Provide a copy of their official G.E.D. test scores.
- 5. Applicant must meet with a Navigator* and enroll in the "Getting Your Educational Direction" seminar series OR enroll in the RRCC Gateway program**

Submitting the Application:

- Do not use binders, notebooks or page protectors.
- Applications in transit at the time of the deadline are considered late and will not be considered for awards.
- Applications lacking information or missing attachments are incomplete.
- Late and/or incomplete applications are not considered for awards.

Students receiving scholarships are expected to maintain an RRCC minimum GPA of 2.0, complete "Getting Your Educational Direction" seminar series or by enrolled in the RRCC Gateway program. They must also be enrolled in a minimum of 3 credit hours. Recipients must fulfill the requirements of the award listed in the notification letter to fully utilize the award during the academic year. If the scholarship student drops below the minimum GPA or fails to attend "Getting Your Educational Direction" or discontinues the RRCC Gateway Program, a discontinuance of the scholarship may result. Additionally, the student may be required to provide reimbursement for the current awards issued.
