COURSE DESCRIPTION:

Introduces basic information on the definition, formation, identification, and uses of rocks and minerals. Credit hours: 1

COURSE OBJECTIVES:

Upon completion of this course, students will be able to: Identify minerals using physical and some optical properties Recognize the most abundant rocks of each major rock type List the modes of occurrence of each major rock type including localities in Colorado

COURSE REQUIREMENTS / EXPECTATIONS

A lot of class time will involve hands-on practice with mineral and rock identification.

Field Trips: On Saturday, September 16, we will take a 30-minute field trip to look at rocks on the Red Rocks campus. We will also have a one to two hour field trips on both Saturday, September 23 and 30 to see examples of the various rock types in the local area. All students must sign a waiver prior to the field trip, and carpooling is strongly encouraged. Further details will be given on Saturday, September 16.

Class Assignments/Exams:

Quizzes: There will be two quizzes in the class as noted on the class schedule. The quizzes will be open book for any PRINT notes/references you care to use.

Labs: There will be four sample identification labs in this class. You will identify minerals, igneous rocks, sedimentary rocks, and metamorphic rocks. The labs will be done in the classroom and you may work with one classmate. You may use your textbook in these labs and you will also be given supplementary material in class.

Assignment: There is one take-home assignment in this class. The take-home assignment consists of three parts. All three parts of this assignment will be completed INDIVIDUALLY (no collaboration with classmates or anyone else) but will be "open book" for any PRINT notes/references you care to use. Part One of the take-home assignment will be given to you at the end of the day on Saturday, September 16, and you will need to submit your work as a .doc, .docx, .pdf, or .rtf document using the DropBox on D2L no later than 8:00 AM on Saturday, September 20.

Parts 2 and 3 of the take-home assignment will be given to you at the end of the day on Saturday, September 23, and you will need to submit your work as a .doc, .docx, .pdf, or .rtf document using the DropBox on D2L no later than 9:00PM on Monday, October 2.

<u>No late work will be accepted</u>, so be sure to start early and get any technical help you need with D2L well in advance of the deadline. I will have your final grades posted no later than **Thursday, October 5**.

ATTENDANCE POLICY

Attendance and Participation: Attendance for all parts of this class is mandatory. Missing 5 hours or more will result in your receiving an "F" for your final class grade, regardless of your performance on graded material. Attendance and participation also count directly as 20% of your grade when calculating your average. In addition, there will be graded activities throughout class time, and there is no make-up for any of these for which you are not present. Missing one part of class also usually makes understanding of the next part difficult or impossible, since most of what we will be doing builds upon previous activities. Furthermore, you need to arrive on time each day and after breaks. Tardiness will result in a reduction of your attendance/participation grade, up to the maximum number of points. Likewise,

sleeping during class, not pulling your weight in group activities, and any other type of "checking out" will also result in loss of these points.

Per school policy, students who do not attend the first day of class will also be dropped from the class.

MAKE-UP / LATE WORK POLICIES / EXTRA CREDIT

Late work will NOT be accepted and is due at the START of class!! Extra credit is not offered in this class.

Students who engage in any type of academic dishonesty are subject to both academic consequences as determined by the instructor and to disciplinary action. Any student guilty of any form of academic dishonesty will receive a grade of ZERO for that assignment or exam and will be subject to additional disciplinary action, as outlined in the RRCC disciplinary procedures.
