Responsibilities

Teach using traditional and alternative methods of instruction (computer-aided instruction, interdisciplinary approaches, self-paced, on-line, etc.). Maintain full-time teaching load. Enlist the support and active participation of practicing clinicians and health care institutions in the clinical education of Sonography students. Demonstrate sensitivity to different learning styles. Assist with the organization, structure, and scheduling of the clinical curriculum, practicums, and rotations in accordance with established educational standards and practices. Support the student evaluation system to assess student progress and documented achievement of essential practice skills and clinical competency objectives for each clinical discipline. Monitor the quality and effectiveness of the supervised clinical practicum instruction and regularly evaluate the teaching effectiveness of the clinical instructors and affiliate faculty involved with the program. Aid in the recruitment, hiring and supervision of part time instructors in the Sonography program. Lead all accreditation efforts to meet required processes and deadlines. Coordinate with other faculty in curriculum planning, development, delivery and review. Recruit, advise and retain students. Hold regular office hours. Participate in departmental governance and assume department duties as needed. Participate in department, divisional and college-wide professional development activities and committees. Serve as a liaison between Red Rocks Community College and the community. Fulfill the direct teaching, indirect teaching, professional development and service obligations of full-time faculty.

Bachelor's degree from an accredited institution. A Master's Degree must be earned within one year of hire. Five years full time experience as a registered (ARDMS) sonographer (ABD/OBGyn). A strong commitment to effective teaching at the community college and an understanding of its philosophy, role and mission. Proficiency in areas of curriculum design, program administration/evaluation, instruction and counseling. Credentialed or ability to obtain credential, in good standing, in sonography by the American Registry of Diagnostic Medical Sonographers.
