Position Overview

In collaboration with the director, provide a quality program for young children at The Children's Center, as well as mentoring and leadership of ECE students working in the center.

Responsibilities

Provide quality teaching by collaborating with Toddler/Preschool teachers/primary caregivers, families and Center director to meet children's needs in care. Plan and execute developmentally appropriate activities for primary children based on their needs and interests on a weekly basis. Keep anecdotal records on each child and provide periodic developmental summaries. Mentor Assistant Toddler/Preschool teachers in Center and model quality care giving practices for students in the ECE program. May be required to mentor ECE students during the RRCC school semester. Support family interactions by holding at least two parent teacher conferences a year with each family, conveying written information about each child's interests and needs at least once a week. Interact with other staff members to coordinate resources and center maintenance for learning environment of young children. Use appropriate conflict resolution skills with other staff. Assume directorship in absence of the director when needed.
