

## Red Rocks Innovations in STEM Education IDEA Lab SolidWorks Technician Work Study

Job Description: As a Red Rocks Innovations in STEM Education (RISE) IDEA Lab Technician, you will be expected to work approximately 10~20 hours per week during office hours which are 8:00 am ~5:00 pm Monday through Friday during times when fall and spring classes are in session. All hours will be as a staff/resource person for the IDEA Lab (<a href="www.rrcc.edu/idea-lab">www.rrcc.edu/idea-lab</a>). The number of hours you work will be at the discretion of the Director of RISE and based on your schedule. There may be additional weekend/evening events or projects that will be necessary. Job duties include but are not limited to:

- Staffing the IDEA Lab and providing appropriate information and mentoring to students, RRCC faculty and industry partners
- Assisting design teams with SolidWorks drafting and the creation of models for 3D printing
- Transferring CAD models to 3D printers
- Representing RISE and the IDEA Lab at events both on and off campus
- Marketing for RISE and IDEA Lab
- Participating in bi-weekly staff meetings
- Maintaining and securing IDEA Lab equipment
- Creating a safe work environment
- Other duties as assigned

**Job Requirements:** You must be eligible for student employment (enrolled in a minimum of six (6) credit hours for the fall 2015 semester) and be awarded work-study through Red Rocks Community College to apply.

- Excellent written and verbal communication skills
- Demonstrated organizational skills
- Experience with SolidWorks software and 3D modeling
- Ability to serve as a positive role model for RRCC students
