

Explanation, demonstration and practice of Dialogic reading techniques developed from the Stoney Brook Reading and Language Project (Grover Whitehurst 1992). Participants will explore the "how to" of transforming the child's traditional role from that of passive listener to active storyteller. These various techniques of prompting, evaluating, expanding and recall can be used with young children ages 21/2 – kindergarten to learn more from books; improving vocabulary, word recognition and overall comprehension. This workshop brings to life how learning takes place within the relationship between the reader and the learner as they share conversation and the love of books to build oral language and ultimately becoming proficient readers. Dialogic reading is perfect for parents or teachers of young children to enhance their precious time together while strengthening literacy skills for school readiness and a smart future.

This Mindful Communication training is part lecture, part discussion, and many experiential exercises. Participants will also work in dyads (with a partner) or triads (two partners) on guided mindful communication exercises.

Mindful listening and mindful speaking are the cornerstones for effective communication. They are the gateway to clear understanding and connection. This mindfulness training is an exploration of how we communicate with others. Through the practices of mindful speaking and listening we learn to be present in the moment, and learn skills to be effective communicators. Mindful communication consists of mindful listening and speaking. Mindful listening helps to provide insights and understanding to the speaker, allowing the speaker to truly feel heard. Mindful speaking helps us come from a place of authenticity, where we are not talking from autopilot but truly present to the moment and the situation. Both involve awareness and create connection.

This process of mindful communication can have a profound impact on the way we communicate. This training helps build skills for effective communication building trust between the speaker and the listener, allowing relationships to flourish.

# **Colorado Competencies**

Colorado released Colorado's Competencies for Early Childhood Teachers and Administrators to support teachers and administrators in their professional development. These competencies are now reflected on training certificates accepted for renewal of licensure.

What are the content areas of Colorado's Competencies for Early Childhood Teachers and Administrators?

Child Growth and Development, Child Observation and Assessment, Family and Community Partnerships, Guidance, Health, Safety and Nutrition, Professional Development and Leadership, Program Planning and Development, and Teaching Practice.

The competencies are broken into four levels:

Level 1: Demonstrates basic skills and knowledge to support quality early child-hood care and education.

Level 2: Demonstrates skills and knowledge from level 1 plus applies skills and knowledge to implement effective early childhood environments and experiences for young children.

Level 3: Demonstrates skills and knowledge of previous levels plus, designs, plans, and analyzes policies, procedures and practices that are optimal for young children.

Level 4: Demonstrates the skills and knowledge at previous levels plus: advances the field of early childhood education through advocacy.
