

Required and Recommended RRCC Transfer Courses for a B.A.S. at Regis University



Funded in part by the National Science Foundation

Students interested in articulating their A.A.S. degree from RRCC to Regis University will earn a Bachelor's of Applied Science-Interdisciplinary degree, no matter what discipline is chosen. Interdisciplinary means that the student can take a variety of self-guided classes in Regis University's School of Humanities in order to achieve a more rounded degree unlike a focused degree in management or business, for example. The diversity will be reflected on the transcript, not on the diploma.

The B.A.S. degree will transfer into some Master's programs at Regis University. If you know that you are interested in pursuing a Master's degree, keep in close contact with your Regis advisor. You may need to take an alternative track (course selection) at Regis to adequately gain the necessary courses for Master's degree and transfer options. A general B.S. track will offer more options than a B.A.S. degree.

A student must earn an A.A.S. degree in WQM before transferring to Regis. Concurrently, or after earning the A.A.S., a student must enroll in additional credits to transfer to Regis University for a B.A.S. Below are the required and recommended courses at RRCC that offer the fasted pathway to a B.A.S. Once accepted at Regis, a student will take an additional 33 credits for the full 128 credit Bachelor's degree.

IMPORTANT!!! Financial aid at RRCC will flag you upon completing an A.A.S. degree in WQM. Paperwork will need to be submitted in order to continue receiving financial aid for additional credits at RRCC. Allow adequate time for this process. Contact Financial Aid and Regis for details.
