



PROMISSORY NOTE Daniels Brothers Memorial Endowment Gap Loan for VA Student Books

IMPORTANT INFORMATION ABOUT YOUR LOAN: (Terms and Conditions)

You may only apply for or receive one short term gap loan per semester. Loans may not exceed \$400. Only active-duty military and veteran students who are eligible for and have previously applied for VA benefits may request this short-term loan. NO EXCEPTIONS.

Barnes and Noble bookstore charges will post electronically to your student account. THIS LOAN IS LIMITED TO \$400 - TEXTBOOKS ONLY.

Remember, this is a loan application. By signing below, you are acknowledging this financial obligation and agreeing to the "Important Information About Your Loan-Terms and Conditions". You will not be charged a processing or administrative charge for this loan. If you receive financial aid or VA book benefits, this loan must be repaid in full at the Cashier's Office-Lakewood campus once you receive those funds. By signing below, you are authorizing this loan to be deducted by RRCC from any financial aid check (if applicable).

If for any reason you refuse your financial aid, are found ineligible for financial aid or VA benefits (including but not limited to unsatisfactory academic progress, not attending class, not providing required documents, or any other reason) you acknowledge you still owe this loan and will pay all amounts due including any Collection costs incurred. All loans must be paid in full within the semester. Pay your loan back at the Cashier's Office on the Lakewood campus. You may receive a financial hold on your student account which will prevent the ability to register, and/or withdraw or drop classes online, for any classes taken within the Colorado Community College System.

In the event you fail to repay this loan by the end of the term, you agree to the release by Red Rocks Community College (RRCC) of any and all records or information maintained by RRCC. The records shall be released to any agent of RRCC for use in collection of the unpaid indebtedness together with any late fees, collection costs, or other fees which may apply. If you are delinquent on your student account from a prior semester, you will not be eligible for this loan.

PLEASE PROVIDE A SHORT STATEMENT ABOUT YOUR NEED FOR TEMPORARY FUNDING TO COVER BOOKS. PLEASE ATTACH A PRINTOUT FROM THE ROCK (PORTAL) SHOWING YOUR SCHEDULE, THE BOOKS REQUIRED, AND THE COST OF EACH BOOK.
