Developmental Mathematics: Volume II, Rockswold and Kreiger, Plus MyMathLab

COURSE DESCRIPTION:

Develops algebraic skills necessary for manipulating expressions and solving equations. Topics in the course include radicals, polynomials, factoring, rational expressions, quadratic equations, absolute value equations and inequalities, systems of linear equations, related applications, and math learning strategies. This course prepares students for College Algebra.

Credit hours: 4

Grade of C or better in MAT 050, or appropriate placement score

1. Demonstrate knowledge of and the ability to perform algebraic manipulations with radicals, complex numbers, polynomials, and rational expressions.
