If you have taken qualifying college-level coursework you would like to use for placement purposes, you may provide an official transcript to the Student Records Department to have that information reviewed.

ACCUPLACER RETEST POLICY

The exam can be taken up to three times before the first semester of enrollment.

For all subsequent semesters you are allowed one opportunity to retest.

Retests can be given as soon as the following business day after the first, second and third tests.

Retests cannot be given on the same day according to the College Board.

A Student ID number (S#) and a valid, government-issued photo ID or RRCC Student ID are required for all Accuplacer tests, including retests.
