Job Summary:

Instructional assignment is comprised of teaching 3- 3.5 hour-long hands-on cadaver workshops to healthcare professionals or students enrolled in healthcare or related courses in high school, college or vocational educational institutions. This is a variable, flexible part-time position that typically comprises 1-6 workshops a month. Perform instruction-related duties and responsibilities in accordance with the philosophy, policies, and procedures of the Colorado Community College System.

Essential Functions:

95% of time - Teach day, evening, and/or weekend cadaver workshops in accordance with approved course of study utilizing traditional and alternative methods of instruction. Present instructional material effectively, maintain professional and courteous interaction with students and employees, model dignity, decorum and respect for human remains, demonstrate sensitivity to different learning styles, encourage student engagement, and properly prepare and return the cadavers in a safe and secure location as outlined by the Cadaver Program Supervisor.

5% of time - Assist the Cadaver Program Supervisor in maintaining inventory control of equipment and supplies.
