We would like to update families in regards to the recently issued adjustments affecting morning starts within the school district this year. In our best effort to continue supporting you, we will continue to be offering school age child care. Here are some details to please be aware of:

If you are signed up for either before and after school care - or just the after school care on these days - you will only be charged the afternoon rate. This will show up as a separate line item on your statement.

No parent or guardian is charged for these mornings unless they have signed up for care.

Sign up is the same process we use for full days and school breaks: It is completed through this link at least 2 weeks prior and the rate will be \$21.00

We will do our best to meet the needs of our families and clients. It is important to keep in mind that some schools will require a cap due to current staffing that are high school students, who are unavailable to work in the mornings.

Halloween

Many of your students will be participating in the Halloween parade/parties at Mitchell. If your student wishes to wear his/her costume to Red Rocks after school that is fine but they will not be able to wear masks.

Furthermore, if you plan on picking your student up from school that day please let me know prior to the end of the day!

Weather Updates & Policies

As weather begins to get cooler out please send your student with the appropriate gear. Jackets, boots, hats and gloves are recommended in order for them to be able to go outside!

We follow Jefferson County Public Schools policies. If the schools close due to inclement weather or road conditions, RRCC SACC also closes because we cannot access the school building. RRCC SACC closures related to district closures will not be reimbursed, in accordance with your contract.
